- A. By an agreement called "South Australian Building Industry Redundancy Scheme Agreement 1996" which came into effect on the 22nd day of October 1996, ("the Redundancy Scheme Agreement") a copy of which is attached being an agreement made between the Unions and the Master Builders Association of South Australia Inc ("MBA"), MBA representing certain employers operating in the building industry in South Australia, the Unions and the MBA agreed to establish a scheme to provide for redundancy payments to be made to employees of the members of the MBA engaged in the building industry in the State of South Australia.
- B. The Employer and the Unions agreed to comply with the terms of the Redundancy Scheme Agreement being the agreement attached hereto to ensure that employees of the Employer receive the redundancy entitlements referred to in that agreement subject to the terms of that agreement.
- C. Operative Part
  - 1. The Employer and the Unions agree to be bound by the Building Industry Redundancy Scheme Agreement as if it were set out in full in this agreement and as if each reference in it to participating employers is (except where the context otherwise requires) a reference to the Employer.
  - 2. The Employer and the Unions agree that any variation made by the MBA and the Unions to the Building Industry Redundancy Scheme Agreement will be binding upon the Unions and the Employer.
